



Wisconsin Statute § 118.125 thiab hauv Family Educational Rights thiab Privacy Act (“FERPA”), Tsoom Fwv tsab cai, hais kom hauv Green Bay Ib Cheeb Tsam Tsev Kawm Ntawv Dawb nrog rau yam puav zam tau, los tuav nej qhov sau ua ntawv tso cai kom qhia ib tug neeg twg xwsi nej tus menyuam tej keeb kwm kawm ntawv uas tau zwm cia. Tsuas yog, tej zaum hauv District yuav muab tej lus tso cai tau “directory information” losis “directory data” uas tsis tas sau ntawv tso cai, nauj cam li nej hais rau hauv District txhob ua xwb uas tau pom zoo los ntawm cov thawj coj, Board of Education Tsab Cai 347 thiab Txoj Cai 347. Qhov tseem ntsiab ntawm directory information yog cia hauv District muab tej lus ntawm koj tus menyuam tej kev kawm txuj uas tau khaws cia txog yam puav tso tawm rau tus twg los saib tau. Yam piv xam no ces yog xwsi:

- Qhov khoakas, qhia nej tus menyuam seb yog ua dab tsi nyob rau kev ua yeeb yaj duab;
- Cov phau duab ib xyoo ib zaug thiab/lois hoob tas nrho tej duab;
- Pawg kawm tau ntawv zoo losis lwm yam sau cia txog qhov kev lees paub;
